All exhibitors must be from within Wales with priority given to local producers and members of Vale of Glamorgan Farmers' Market

There will be two sorts of stalls available at this year's show.

- 1. For the selling of locally produced food items no hot food.
- 2. Cooked food stall selling food to be consumed on the show day
  (Restricted to 6 stalls in total plus 1 ice cream, and 1 tea & coffee)
  Cooked stalls priority will be given to primary producers from within the Vale

Those selling alcohol must have a personal licence, the Food Court itself will not be licensed so alcohol for sale is for consumption **off** the show field only. No alcohol can be sold by the glass.

Please note: We will have washable flooring, waste water collection in the cooked food area. Environmental Health are also insisting on all cooked stalls having hot and cold water. We will have space for catering vans/trailers, and anyone wishing to have more space can book a double stall.
